In doing so Joan Woodward offered lasting insights into issues of levels of hierarchy and spans of management control - issues that today might be discussed in terms of "layering" and "process re-engineering". Woodward's work was a springboard for much subsequent research and many of her specific observations have been widely debated and challenged.
